

RESOLUTION NO. 2019-1672

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PRESCOTT, YAVAPAI COUNTY, ARIZONA, AUTHORIZING THE CITY OF PRESCOTT TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT (“IGA”) AND MUTUAL AID COMPACT WITH THE ARIZONA DEPARTMENT OF EMERGENCY AND MILITARY AFFAIRS FOR MUTUAL ASSISTANCE DURING EMERGENCIES (CITY CONTRACT NO. 2019-167); AND AUTHORIZING THE MAYOR AND STAFF TO TAKE ANY AND ALL STEPS NECESSARY TO ACCOMPLISH THE ABOVE.

RECITALS:

WHEREAS, the City of Prescott (“City”) and the Arizona Department of Emergency and Military Affairs wish to enter into an IGA and Mutual Aid Compact to provide for the interchange of mutual aid assistance in coping with future community disaster or emergencies; and,

WHEREAS, the City, which has expertise in managing and responding to community disasters and emergencies, may have need for mutual aid assistance responding to future community disaster or emergencies, has resources to assist other governmental entities in responding to such disasters or emergencies, and has authority pursuant to A.R.S. §26-308 to enter into contracts and agreements for such purposes; and,

WHEREAS, the Arizona Department of Emergency and Military Affairs has expertise in managing and responding to community disasters or emergencies and has resources to assist other governmental entities in responding to such disasters or emergencies; and,

WHEREAS, the City of Prescott and the Arizona Department of Emergency and Military Affairs have the authority to enter into the foregoing agreement pursuant to A.R.S. §§11-952 and 26-308.

ENACTMENTS:

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PRESCOTT AS FOLLOWS:

SECTION 1. THAT the City of Prescott hereby approves the IGA and Mutual Aid Compact (City Contract No. 2019-167) with the Arizona Department of Emergency and Military Affairs for administering mutual aid assistance.

SECTION 2. THAT the Mayor and staff are hereby authorized to execute the attached IGA and Mutual Aid Compact (City Contract No. 2019-167) and to take any and all steps deemed necessary to accomplish the foregoing.
