To whom it may concern,

We are submitting a comprehensive sign package for The Burmister, located at 120 W. Gurley St. Parcel # 113-15-115. The first sign would be an entrance sign. Our client has indicated that many people are under the impression that Bashford Court includes the businesses inside The Burmister. He would like to delineate the two properties. The size, color and material would be the same as the specs for the Bashford Court entrance sign. (2' aluminum and acrylic with backlit LED lighting, 42 sq. ft.) The existing Old Capitol Market sign will be removed. No other exterior tenant signage on either walls or windows would be allowed.

We are also applying for two 20" x 20' non lit signs. One is to be installed on the east side of the building, and visible heading west on Gurley. The second will be the same size and for the parking lot back entrance. Each of these signs is 33.33 sq. ft. bringing the total to 108.66. Signs have been approved by the Prescott Historic Preservation Committee. Please consider that we are asking for less signage than the approved Bashford Court.

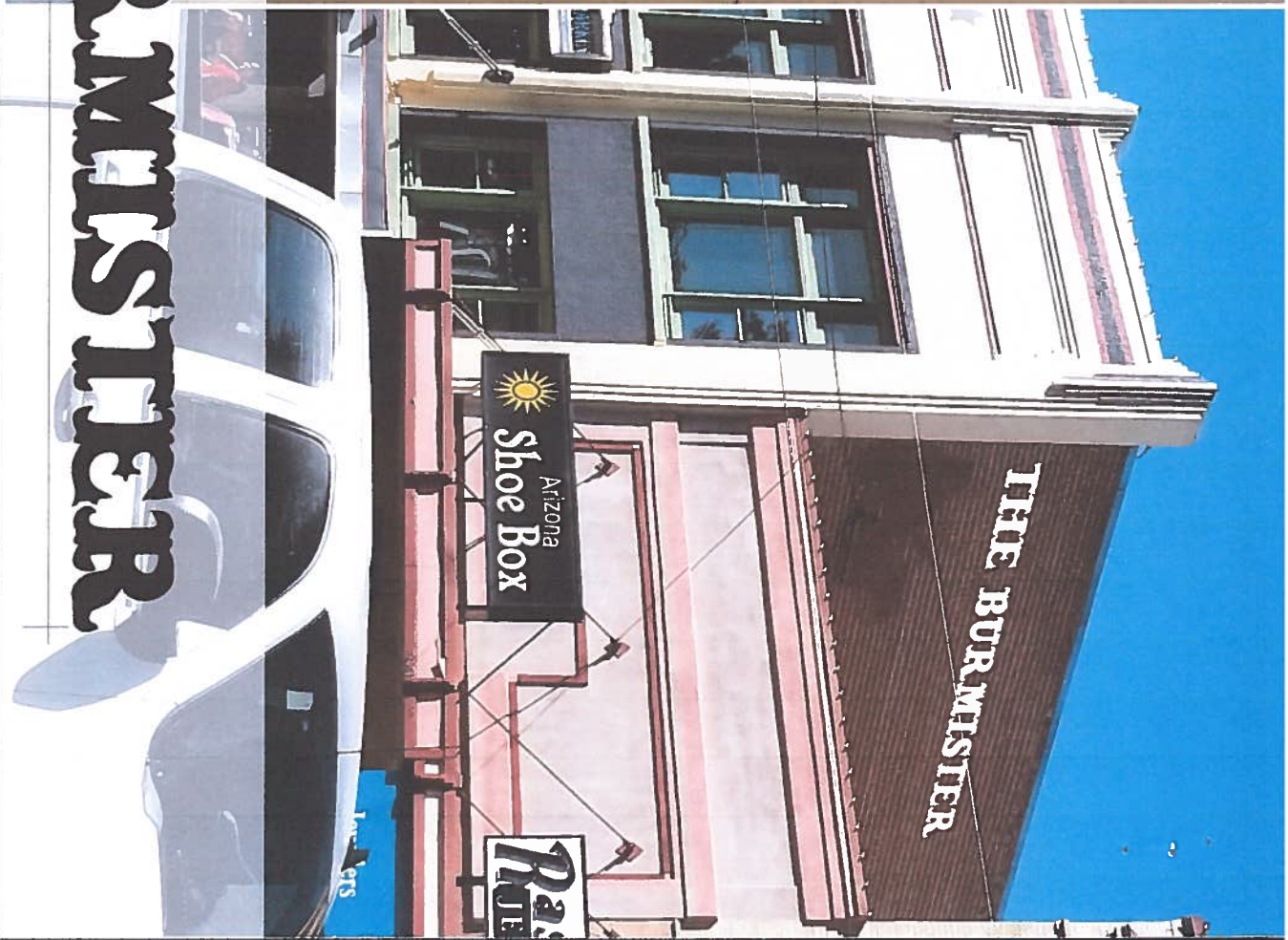

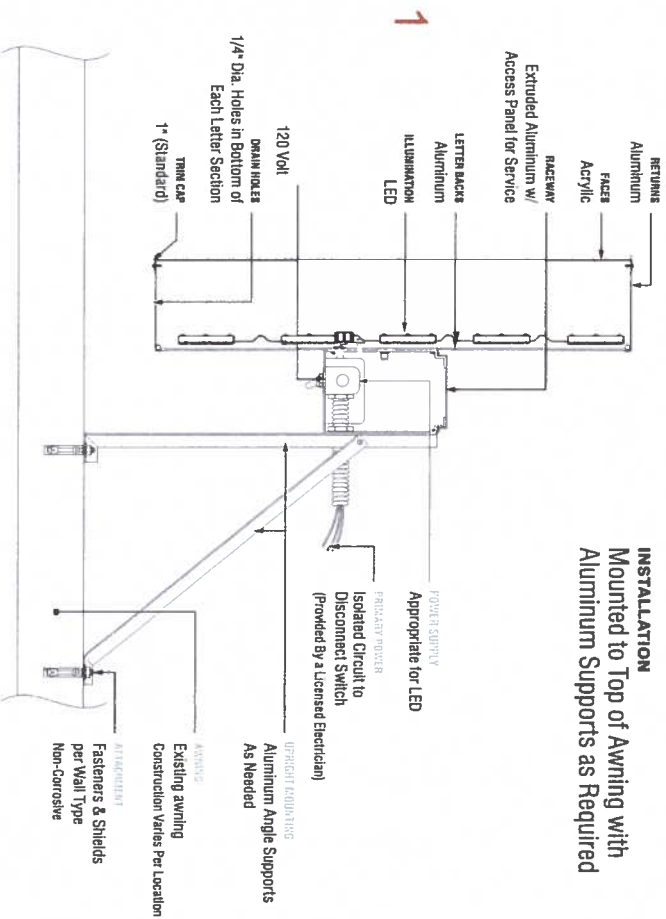

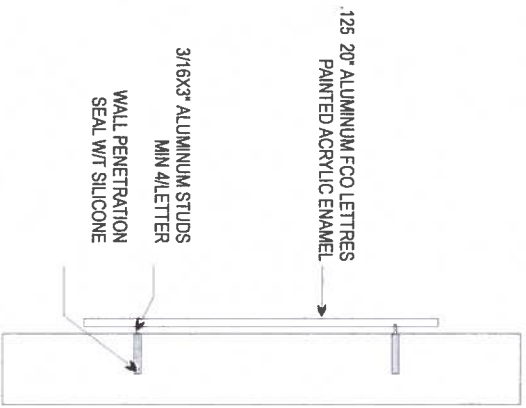
